We believe that women and children experiencing homelessness and poverty deserve a safe and caring place to re-establish their lives. We believe that every woman, no matter what her circumstances, is worthy of respect and is a valuable human being just as she is.

The Gathering Place exists to offer women a safe haven, resources for self-sufficiency and opportunities to acquire new skills. Women who are able to meet their immediate and urgent needs can then collect their inner resources and make positive life changes for themselves and their children.



At The Gathering Place, women meet other women who may have traveled down the same road. In each other's company they share their experiences, give each other advice and offer friendship.

Mission

The Gathering Place supports women and their children experiencing homelessness or poverty by providing a safe daytime refuge and resources for self-sufficiency.



Programs at The Gathering Place

This fiscal year we celebrated our first year in the beautiful Kal and Joyce Zeff Center, new home to The Gathering Place. Some highlights or our accomplishments and activities include:

BASIC SERVICES

Women and children made a total of 79,721 visits to The Gathering Place. That included 6,066 individual women, averaging 6,643 visits each month.

A total of 441 nights-off-the-streets were provided through motel vouchers during the year.

Lack of affordable and reliable transportation is a barrier for people who are seeking employment, education, training or housing. The Gathering Place distributed an average of 5,790 bus fares to women and their children each month.

FOOD PROGRAM

The buffet breakfast, full-service hot lunches and hearty afternoon snacks helped women and their children to save precious cash resources they could apply towards rent or utility expenses. Eating meals at The Gathering Place also provides a community of support where people visit, share experiences and encourage one another. The Gathering Place served 69,931 meals, for an average of 5,828 meals each month. In addition, through Betsy's Cupboard, our emergency food and supply bank we supported an average of 405 families with food and toiletry baskets as well as baby supplies each month.

FAMILY AREA

In the Family Area, staff and volunteers provide a safe and nurturing environment for children visiting The Gathering Place with their mothers. Each month an average of 660 children visited the Family Area at The Gathering Place to do the real work of childhood – play.

PERSONAL GROWTH & LEARNING PROGRAMS

The Gathering Place actively collaborates with private and public organizations across the community to provide an array of programs that women can select from to begin rebuilding their lives. Many of the successes experienced below are a result of these collaborations.

An average of 33 students attended G.E.D. tutoring sessions each month. During the year, 40 tests were passed and 5 students completed their G.E.D.

Our computer lab, staffed by volunteers, received 6,506 visits.

Attorneys provided by Qwest Communications offered 83 free legal inquiry sessions to the women we serve, often eliminating outstanding judgments that barred women from employment or housing.

Bridget's Boutique provided high-quality clothing to 4,288 women through the Hand Me Up donation program of Heritage Cleaners. Additionally, SOL Lingerie fitted 427 women for new and gently-used bras.

Through the year, 141 free haircuts were given to women and children.

HOUSING STABILIZATION

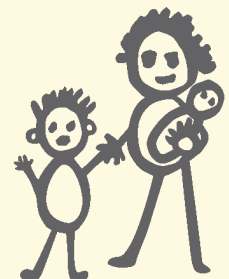
With funding from Denver's Road Home, The Gathering Place continued our Housing Stabilization Program. This program assisted 38 homeless women find housing by providing case management, rental assistance, utility assistance, furniture, help obtaining legal identification, transportation assistance, and access to homeless court to clear up outstanding legal issues. The Gathering Place Association provided "Welcome Home" gift baskets to all the women served, which contained necessary housekeeping supplies.

ARTS PROGRAMS

At The Gathering Place, we believe in the power of creativity to heal and rest the mind. The Card Project provides a safe and supportive environment for women to express themselves artistically and an opportunity to experience growth and obtain financial reward. Card Project artists collectively earned \$46,763 through the sale of individually hand-made greeting cards.

An average of 12 women per month participated in the knitting group.

Art classes were offered through The Other Side Arts and were attended by an average of 19 women per month.
