# From the President/CEO

Dear Friends,


As I look back to 2009-2010, I think of a year of contrasts. We worked hard and were blessed with some of the greatest successes we have ever achieved. And we did this in one of the worst economies we've faced; an ever-growing number of people came to us with complex needs, while our resources—and those of many of our donors and collaborative partners—were shrinking.

We were grateful to offer comfort and safe refuge to those who came to us for the first time, were homeless for the first time, and for those who were beginning to find their voice, their treatment, and their community. We celebrated with 40 women who were housed through our Denver's Road Home housing stabilization program and with 12 women who received their GED certification. And artists from The Card Project received over \$31,000 in payment for their handcrafted works of art.

At the same time, our nation's economic recession took its toll on The Gathering Place this year. We were fortunate to have made it to this point without needing to cut programs, services, or staff, but had trimmed our budget as far as possible over the past two years. In planning for the 2010-2011 fiscal year, we faced a financial reality that forced us to make a number of difficult decisions including discontinuing some programs, changing our hours of operation, and laying off four of our staff members. We based our decisions on the most thorough evaluation of our organization ever completed, and were successful in maintaining our philosophical essence and core services.

In the midst of this challenging time, we have been overwhelmed by an outpouring of community support and encouragement. Those who could give monetary and in-kind donations did so to the best of their ability. Others generously contributed their time and service. Our community grew stronger as we faced momentous challenges together. I cannot help but be an optimist and, as the economy begins to recover, look forward to a new season of renewal and rebuilding. Thank you for joining us on this journey and for helping us continue to serve those who seek refuge at The Gathering Place.

# Our Philosophy

We believe that the women, children, and transgender individuals who come to The Gathering Place deserve a safe and caring place to re-establish their lives and that all people, regardless of circumstances, are worthy of respect and are valuable human beings just as they are.

We also believe that it is not our place to judge anyone. We are here to offer a safe haven, resources for self-sufficiency, and opportunities to acquire new skills. Our experience tells us that women who are able to meet their immediate and urgent needs can then call upon their inner resources and make positive life changes for themselves and their children.

When The Gathering Place was founded in 1986, women and children made up approximately 10% of the homeless population in Denver. Today, they comprise more than 50% of our city's homeless population, and families are the fastest growing segment of those who are newly homeless.

Every day at The Gathering Place, individuals meet others who share similar life experiences or circumstances. In each other's company, these individuals share their stories, give each other advice, offer friendship and support, and build the type of community that makes The Gathering Place such a special space.



Nearly every human services organization has been changed by the economic recession that continues to affect our nation. For women and children experiencing homelessness and poverty, the economy has meant an additional layer of vulnerability. During the past two years, we have seen the need for The Gathering Place's services increase by more than 20%. At the same time, nonprofits like ours have seen less support from funding sources whose incomes and endowments have decreased.

The Gathering Place was founded to support women and children in crisis. We are proud to have remained strong during a time when our work is needed more than ever. When financial support diminished from some sources, The Gathering Place used internal reserves that were intended for uncertain times like these. This impact on our financial position is reflected in our financial statements. And in response, we have made strategic decisions to restructure our operations and focus on areas where we can make the biggest difference.

Thanks to our generous supporters, we continue to provide a safe daytime refuge and resources for self-sufficiency for Denver's women and children experiencing homelessness and poverty. The chart above illustrates our diverse sources of income and the financial statements provide a summary of our consolidated financial position for the year ended September 30, 2010.

# Our Programs

We're often asked what a "typical day" at The Gathering Place looks like, and though it seems like no day is typical, we can say for sure that every day is a busy one and that our building constantly hums with activity. When we open in the morning, the first order of the day is breakfast, which includes coffee, juice, milk, and an array of breakfast foods from which to choose.

After breakfast, clients begin to take care of their basic needs, using our showers and laundry facilities, making appointments to visit Betsy's Cupboard, Bridget's Boutique, or Stacey Soom, our on-site employee of the Denver Department of Human Resources. A line may form at our Resource Desk as women seek out information about housing, jobs, benefits, and more. Some use the phones to inquire about resources or to keep in touch with family members. Others go to our computer lab to access resources online, stay in touch with people via email, and work on job or housing applications.

Throughout the morning, we usually hold a number of classes or activities, such as GED tutoring, financial literacy classes, and housing information sessions. Clients are also able to participate in The Card Project where they can create handmade cards that are sold at The Gathering Place and at a number of businesses throughout the Denver metro area. The women receive \$1.50 for each of their cards that is sold.

During the day, mothers and their children check in on the third floor. While the mothers work with our staff and volunteers in the Family Area to identify needs and find resources, the children rest and play in the safety of our bright, beautiful space. On days when the weather is nice, they might venture to the rooftop playground areas (accompanied by their mothers, our staff, or our volunteers), as well, to laugh and run and just be kids.

Around 11 a.m., we start to serve lunch. Families eat first, followed by single adults. The dining room buzzes as the women talk about their lives with each other and share information about resources or services they've accessed or activities they'll be participating in during the afternoon.

Afternoons are much like the mornings in that a variety of programs and activities are offered. On any given day, we might have a health clinic or screenings, pro bono mental health counseling, or pro bono legal services. Clients can also participate in knitting or crochet classes, which happen weekly, and often community groups come to facilitate afternoon activities such as bingo or cookie decorating.

At 3:30 p.m., we serve an afternoon snack, our last meal of the day. The women then start to wrap up their activities and head out. Though our days are not necessarily calm and structured—there are conflicts to manage, mental health crises arise, difficult conversations are had—we share great humor and laughter as well as tears of depression and disappointment. We are, in essence, a daily expression of humanity in all its forms.


